### RULES & REGULATIONS AGREEMENT

1. ALL Little Valley Park Free Summer Youth Program participants MUST have a completed REGISTRATION FORM (Parts 1-3) with all required signatures on file before attending the program. There will be a separate CONSENT FORM for any field trip. Field trip forms must be signed by parent/guardian before trip day. Advance notice for field trips will be provided.
2. Please come to the Little Valley Park Free Summer Youth Program with a positive attitude. You must wear your camp t-shirt, sneakers, and have your own labeled water bottle (no flip-flops, sandals, or open-toe shoes). We strongly recommend a cap or shade hat.
3. Upon arrival, please sign-in with a volunteer each day. At dismissal, please see a volunteer who will log your departure time each day.
4. Please arrive on time at 8:30 am and remain until the program ends at 12:30 pm. You may NOT leave the park during program hours for any reason. If you are feeling ill or have reason to leave early, a guardian must escort you home. All children must be picked up/released by 12:30 pm.
5. Please bring a healthy snack each day. Please put your name on your snack bag before placing it in the refrigerator.
6. Please wash/sanitize your hands UPON ARRIVAL, BEFORE YOU EAT, and AFTER USING THE BATHROOM.
7. Please inform a volunteer when leaving an activity to use bathroom, or for other reasons.
8. Please be respectful of others; treat others as you want to be treated. Bullying, profanity, and disrespectful behavior will NOT be tolerated. NEVER fight. Resolve conflict with good words. Help someone in trouble. Speak with an adult staff member if you need any kind of assistance.
9. Use materials and equipment properly and in a safe manner. Before using materials or equipment, sanitize your hands. After using materials/equipment it is important that you place them in the “DIRTY” bins for sanitizing. Do not forget to sanitize your work area.
10. Please clean up after yourself after each activity, and help others clean up as well.
11. Always use appropriate language and remember the magic words: PLEASE, THANK YOU, MAY I, and I’M SORRY.
12. Please remember: You may NOT climb on the *outside* of the playground equipment and you may NOT chase after a ball if it rolls into the street or alley. Ask a volunteer for assistance.
13. Please handle books with care. Do not tear pages or write in them. Sanitize your hands before selecting a book. Return books to the “DIRTY” bin. Read a few books this summer! Free books will be available at the end of each week for you to take home and keep in your personal library.
14. Please be advised that if you do not follow the rules, you will be discharged from the program by the supervisor. Parents/guardians will be notified by the program supervisor.

**Participant Liability Waiver Release & Indemnification**

This VOLUNTEER RELEASE AND WAIVER OF LIABILITY (this "**Release**") is executed as of the date printed below by the undersigned, as the legal guardian on behalf of a minor child or minor children, (collectively "**I**", "**me**" or "**Child**") in favor of Borough of Penbrook, and all entities, associations, officers, volunteers, representatives or individuals associated with Borough Penbrook (the "**Borough**").

I desire to enroll my Child for participation in and allow my Child to engage in Borough activities (the "**Activities**"). I understand that the Activities may include, but are not limited to, participation in the Borough of Penbrook Little Valley Park FREE Summer Youth Program.

In exchange for my Child being allowed to participate in the Activities and for other good and valuable consideration, the receipt and sufficiency of which I acknowledge, I hereby freely, voluntarily, and without duress execute this Release and intending to be legally bound agree to the following terms:

1. Assumption of Risk. I am aware and understand that the Activities may be inherently dangerous and may expose my Child to a variety of foreseen and unforeseen hazards and risks. I acknowledge that the Child is voluntarily participating in the Activities and I have considered those risks. I hereby expressly and specifically assume such risks, including any and all risk of injury, harm, or loss that I or my Child may incur as a result of participation in the Activities. I am aware and understand that participation in the Activities will require my Child to physically interact with the Penbrook Borough Summer Park Volunteers and other children. As such, despite reasonable mitigation efforts on behalf of the Borough, physical interaction with the public at large may pose some unavoidable risks to the Child due to the COVID-19 pandemic. I understand that participation in the Activities may expose the Child and others to unavoidable COVID-19 community spread. As such, I expressly and specifically assume the risk of injury or other harm with respect to COVID-19 and possible exposure to COVID-19 resulting from or in any way related to the Activities.

2. Medical Treatment. I hereby give consent and authority to the Borough to obtain medical treatment on behalf of my Child if they are injured or require medical attention during participation in the Activities. I understand and agree that I am solely responsible for all costs related to such medical treatment, medical transportation, and/or evacuation. I hereby release, forever discharge, and hold harmless the Borough from any claim whatsoever in connection with such treatment or other medical services.



3. Release and Waiver. I hereby fully and forever release and discharge the Borough from, and expressly waive, any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that may arise from the Child's participation in the Activities. I agree not to make or bring any such claim or demand against the Borough, and fully and forever release and discharge the Borough from liability under such claims or demands.

I UNDERSTAND THAT THIS RELEASE DISCHARGES THE BOROUGH FROM ANY LIABILITY OR CLAIM THAT I OR MY CHILD MAY HAVE AGAINST THE BOROUGH WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, PROPERTY DAMAGE, OR PROPERTY LOSS THAT MAY RESULT FROM THE ACTIVITIES, WHETHER CAUSED BY THE NEGLIGENCE OF THE BOROUGH OR OTHERWISE.

4. Insurance. I UNDERSTAND THAT THE BOROUGH DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE OF ANY NATURE IN THE EVENT OF MY CHILD'S INJURY, ILLNESS, OR DEATH, OR DAMAGE TO OR LOSS OF MY PROPERTY.

5. Indemnification. I hereby agree to indemnify, defend, and hold harmless the Borough from any and all liability, losses, damages, judgments, or expenses, including attorneys' fees, that it may incur or sustain as a result of the Child's participation in the Activities, arising out of any third-party claim.

6. Authority. I certify that I have authority to execute this Release on behalf of the identified minor(s) Child and that the said minor(s) Child is physically able to participate in the Activities.

7. Photographic Release. I understand and agree that during the Activities, the Child may be photographed and/or videotaped by the Borough for internal and/or promotional use. I hereby grant and convey to the Borough all right, title, and interest, including but not limited to, any royalties, proceeds, or other benefits, in any and all such photographs or recordings, and consent to the Borough 's use of my Child's name, image, likeness, and voice in perpetuity, in any medium or format, for any promotions, publicity or advertising without further compensation or permission.

8. Miscellaneous. I hereby agree that this Release represents the full understanding between the Borough and me and supersedes all other prior agreements, understandings, representations, and warranties, both written and oral, between us, with respect to the subject matter hereof. If any term or provision of this Release shall be held to be invalid by any court of competent jurisdiction, that term or provision shall be deemed modified so as to be valid and enforceable to the full extent permitted. The invalidity of any such term or provision shall not otherwise affect the validity or enforceability of the remaining terms and provisions. This Release is binding on and inures to the benefit of the Borough, me and the Child and our respective heirs, executors, administrators, legal representatives, successors, and permitted

assigns. Section headings are for convenience of reference only and shall not define, modify, expand, or limit any of the terms of this Release.

9. Governing Law. I hereby agree that this Release is intended to be as broad and inclusive as permitted, and that this Release shall be governed by and interpreted in accordance with the laws of the Commonwealth of Pennsylvania, without reference to any choice of law doctrine.

**BY SIGNING, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS RELEASE AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE BOROUGH.**
